Regular Meeting December 20, 2016

The Regular Meeting was called to order by President Klage at 7:30 p.m.

Treasurer's Report: The Treasurer's Report for 11/30/16 was provided in advance of the meeting. As of 11/30/16, the beginning balance in the checking account and general money market account was \$1,677,959.21. After deposits of \$75,476.79 and disbursements of \$215,648.28, the ending balance for those accounts was \$1,537,787.72. The combined balance of the Capital Projects Fund and Equipment Fund, including CD's, was \$1,555,138.33 (\$701,699.41 for Capital Projects and \$853,438.92 for Equipment Fund), giving a total of all funds of \$3,092,926.05. There being no further discussion, Trustee Saas made a motion to accept the Treasurer's Report, seconded by Trustee Saylor. All in favor.

<u>Chiefs' Report</u>: Chief DiMenza summarized some of the call activity experienced since the November meeting. He then spoke about the three paramedic students that have been riding with our ambulance. Two of those individuals requested sponsorship to the fire academy, which he agreed to provide.
